STEAMER CALIFORNIA FAST ON THE ROCKS She Struck Off Tory Island and is Taking in Water Fast—No Panic When Steamer Struck.

London, June 28.—In a fog and rain that rendered Tory Island invisible from the mainland, the Anchor line steamer California, New York for Glasgow, went ashore tonight on the rocks off that island. Wireless calls for help brought speedy assistance from several small gunboats and torpedo boats patrolling the north-west Irish coast for gun runners in connection with the Oster movement. The latest news received here is that the California is stuck fast but is in no immediate danger. She struck with such force that the lower part of her bows was badly crushed and she is taking water through two holes in her forehold and second hold. The steamer which has on board 121 saloon and more than 300 second cabin passengers, lies in five fathoms of water forward and seven fathoms aft. The passengers are now being put on board. There was no panic when she struck. Another liner, steamers and gunboats are standing by and others will arrive during the night. The Anchor line steamer California sailed from New York June 29 for Montreal and Glasgow. On board the vessel were 121 cabin and more than 300 second class passengers. Tory Island lies off the northwestern coast of the county Donegal, Ireland. It is a rocky reef 1.3 miles long and half a mile wide. On the northern end of the island is a lighthouse.

ARCHDUKE FERDINAND AND HIS MORGANATIC WIFE WOUND TO DEATH

Young Student Slays Heir to Austrian Throne. BOMB IS FIRSD HURLED Archduke Warded it Off With His Arm and Escaped Unhurt. SHOT ON RETURN TRIP It Was When the Archduke Was Returning From Visit to Bosnia That Another Tragedy Was Added to Dark History of Hapsburgs.

Sarajevo, Bosnia, June 28.—Archduke Francis Ferdinand, heir to Austria-Hungarian throne, and the Duchess of Hohenberg, his morganatic wife, were shot dead today by a student in the main street of the Bosnian capital, a short time after they had escaped death from a bomb hurled at the royal automobile. The two were slain as they were passing through the city on their annual visit to the annexed provinces of Bosnia and Herzegovina. The archduke was struck full in the face and the duchess was shot through the left abdomen and throat. They died a few minutes after reaching the palace, to which they were hurried. Those responsible for the assassination took care that it should be private. There were two assassins, the first armed with a bomb and the second with a revolver. The bomb was thrown at the royal automobile as it sped to the town hall, where a reception was to be held. The archduke saw the missile hurling through the air and warded it off with his arm. It fell outside the car and exploded, scattering shrapnel over the camp in a second car and half a dozen spectators. As the royal automobile reached a prominent point in the route to the palace an eight grade student, Gavrilo Princip, sprang out and poured a deadly fusillade of bullets from an automatic pistol at the archduke and duchess. Princip and a fellow conspirator, a composer from Trebinja named Gavrilo Princip, barely escaped lynching by the infuriated spectators. They were seized by the police. Both are natives of the annexed provinces of Herzegovina. Their assassination began the dark history occurred just outside the city school. It Begins and Ends With Antitrust Legislation DOWN TO WORK THIS WEEK Senate, However, is Far From Resigned to the Midsummer Season. OPEN REVOLT NOT LIKELY Bills Will Be Put Through by the Familiar Process: Weeks of Debate, Fruitless Efforts to Amend and Then Final Passage. Washington, June 28.—Convinced that there is no other path to adjournment but the one which begins with final legislation, the senate will settle down this week to the steady grind of work on the federal trade commission bill. The senate is far from resigned in the thought of six weeks or more of discussion of trust legislation in mid-summer, but it is not probable that the spirit of open revolt will show itself on the floor and unless senate leaders are at fault in the conditions the three house bills, or legislation designed to cover the same ground, will be passed through by the familiar process, weeks of debate, fruitless effort to amend and then final passage. There is no doubt whatever that if the President would insist in his insistence upon the antitrust program Congress would pass it. The house is in such shape that it would be ready to get away in a few days and the senate is not far behind, as far as appropriation measures are concerned. Many of these bills are still in conference, but if there was any real chance of adjournment it would not take more than a few days to have them finally disposed of. Clayton Bill Difficult Problem. MURDER IN RALEIGH OUTCROWD OF EARLY SUNDAY POKER GAME

Cleve Watkins is Shot to Death By Will Mays. SLAYER MAKES AN ESCAPE Dispute Arose Over an Alleged Gambling Debt and the Shooting Resulted. LETTER FROM WILLIAMSON Progressive National Committee of This State Is Opposed to Any Sort of "Fusion" Unless Colonel Roosevelt Says So. (Special to Daily News.) Raleigh, June 28.—This city experienced the sensation of an early morning murder today when Cleve Watkins was shot to death by Will Mays as the outcome of a poker game in a room over the Lassiter stable on Wilmington street. There were four players and a number of onlookers, and after the fatal shot was fired Mays' gun was taken from him and he was held for a while, but released before the police arrived. Two parties of police in automobiles trailed Mays all afternoon and were still searching for him late tonight with warrants ready to issue. Narragansett was issued for six persons who were mixed up in the gambling that led to the killing of Watkins. It had been going on all night, first set back, then draw and then stud poker. The playing was in the room of Herman Brown. A report is out that a section master for the Southern railway aided Mays in getting away by driving him some distance in a buggy. The name of the man is not known to the office but a "John Doe" warrant for his arrest was issued tonight. Cleve Watkins, the man killed, was a trusted ice wagon driver for the Johnson-Johnson company and had a reputation for being very quiet and unobtrusive man. Mays worked in the Caraleigh Cotton mills and is believed to be both a poor crook and a good hard citizen. He came from Danville, Va., to Raleigh some months ago. So far as it appears to get at the facts it seems that Mays and Watkins had been playing, and Mays claimed that Watkins owed him some money. Mays was angry and started to leave the place when Mays drew his gun and shot him in the chest close in the region of the heart. It required about an hour to get the wounded man to the Rex hospital, where he died within a few minutes. Mays is a native of this county, 35 years old, unmarried and lived with his sister here, having come to Raleigh several years ago from Roanoke.

It was stated tonight that a bill would be introduced in the legislature at Baton Rouge tomorrow, appropriating funds with which to fight the contagion. W. W. Wilkinson, an inmate of the Volunteers of America home, was yesterday sent to a large local hospital supported by the municipality. Today his malady was diagnosed as Bubonic plague. He is recovering and a matter of days, he was also an inmate of the Volunteers of America home. The 27 other members of the home late today were marched through the streets in an abandoned rick in the outskirts of the city where they were placed in quarantine. Every article of furniture and bedding in the home contained was piled in the street in front of the building and a bonfire started. A quantity of second-hand clothing was among the articles destroyed, as it was thought possible that the disease had been communicated by the cast of garments. As the inmates of the home marched two and two through the streets large crowds gathered to watch the unusual procession. It is expected that tomorrow the city and state health authorities will take vigorous steps for a general cleanup campaign. A telegram was sent today to Surgeon General Rupert Blue of the United States public health service urging him to come here on a personal trip of inspection and to detail two experts from the department for special duty.
